## ALIVE! IN CHRIST SCHOLARSHIP (ARCHDIOCESAN)

**Who can apply?** For students of income-eligible families to attend any Archdiocesan parish elementary school. Students of new families are eligible in grades K-4. Students of existing families are eligible in all grades. Scholarship is renewable through grade 8.

**What is the awarded amount?** Between \$1,000 and \$2,000/year

**Where do I apply?** The application can be found at [www.ttef-stl.org](http://www.ttef-stl.org).

**When can I apply?** January 29 – February 28 – The awards are first come, first served!

**How do I qualify?** Scholarships are awarded based on financial need.

## BEYOND SUNDAY ELEMENTARY SCHOLARSHIP (ARCHDIOCESAN)

**Who can apply?** For students of middle-income families to attend grades K-8 at any Catholic elementary school (archdiocesan, parish, or private). Preference given to Catholic families registered in a parish of the Archdiocese of St. Louis. Renewable through grade 8.

**What is the awarded amount?** Between \$1,000 and \$2,000/year

**Where do I apply?** The application can be found at [www.ttef-stl.org](http://www.ttef-stl.org).

**When can I apply?** January 29 – February 28

**How do I qualify?** Scholarships are awarded based on financial need.

## CATHOLIC FAMILY TUITION ASSISTANCE (ARCHDIOCESAN)

**Who can apply?** For students of income-eligible, registered Catholic families to attend grades K-12 at any Archdiocesan or parish school.

**Who can apply?** Registered Catholic families

**What is the awarded amount?** Varies according to family situation

**Where do I apply?** The application can be found at [www.ttef-stl.org](http://www.ttef-stl.org).

**When can I apply?** January 29 – February 28

**How do I qualify?** Grants are awarded based on financial need.

## PARISH EMPLOYEES ENDOWMENT FUND (ARCHDIOCESAN)

**Who can apply?** For students of income-eligible parish employees working 1,000 hours per year to attend grades K-12 at any Archdiocesan or parish school.

**Who can apply?** Income-eligible families whose parents are employed within the Archdiocese of St. Louis and work at least 1,000 hours/year.

**What is the awarded amount?** Varies according to family situation. Where do I apply? The application can be found at [www.ttef-stl.org](http://www.ttef-stl.org).

**When can I apply?** January 29 – February 28

**How do I qualify?** Must be an employee of a parish. Scholarships are based on financial need.

## FRANCIS FUND GRANT

The Francis Fund is made possible by parishioner donations.

**Who can apply?** All day school students

**What is the awarded amount?** Varies according to family situation

**Where do I apply?** Apply via FACTS at <https://online.factsmgt.com/signin/3fxtj>.

**When can I apply?** Applications for next school year due no later than May 1<sup>st</sup>.

**How do I qualify?** Scholarships are based on financial need. Families are required to apply for Archdiocesan scholarships through the Today and Tomorrow Educational Foundation at [ttef-stl.org](http://ttef-stl.org) before applying for a Francis Fund Grant.
