## SFA Fields Work Day

- March 16<sup>th</sup>
- Combining the regular day along with some larger projects
  - Field conditioning is badly needed
- New weed preventative being put down. No longer spraying for hours

### Ideas surrounding a Coach the Coaches concept was discussed

- Mentioned that sometimes there are options offered at the CYC level
- Options to send out weekly communications to coaches as a piece of education
  - Would require someone to manage that communications
  - Suggested that maybe rather than weekly this could just be a preseason piece of content that includes drill recommendations, practice plans, suggestions
- Already have a source for a volleyball coach's clinic but would require payment
- Support thrown out for implementing a program in connection with the mandatory coach's meeting
- Positioning it as a requirement to coach and stressing the importance
- Critical to make sure expectations are set at the start of the season with parents the same way we do
  with the athletes
- Stressed that there needs to be just as much communicated about managing a practice as there is on the drills

## E-Sports

- Presented as a possible need to embrace the future
- Important to identify whether it fits into the mission of our association
- Recommended that tournaments be hosted as a way to gauge interest
  - Additional support thrown out for a tournament approach
- Mixed opinions but people realize that this is something to at least consider
- Concerns brought up that there may be negative reaction from parishioners

#### Basketball Rim

- Rim closest to physical education office is no longer moving up and down
  - Will be investigated and a fix pursued
- Dan and Frank are meeting with AALCO and will ask about a fix
